

## NOTAM A1772/20 and A1773/20

(08 June 2020)

- 1. In General notice #PEL 005/2020 Revision 2 dated 04 June 2020, reference is made to NOTAM A1773/20.
- 2. Paragraph 3 states that "skills tests are allowed, provided that the Examiner or Instructor is authorized by SACAA to conduct a flight test during lockdown."
- 3. Paragraph 4(a) states that "An existing, approved COVID-19 signed procedural checklist for Aviation Training Organisations is acceptable evidence of compliance with paragraph 4(a) of NOTAM A1773/20 during the approved skills test."
- 4. This NOTAM is valid from 01/06/2020 for an estimated 30 days.

ALL INTL, REGIONAL FLT PROHIBITED, IRRESPECTIVE OF THE RISK CAT OF THEIR COUNTRY OF ORIGIN, EXC THOSE FLT AUTHORISED BY THE MINISTRY OF TRANSPORT OR FLT AUTHORISED BY THIS NOTAM. FOR INTL FLT, ONLY TECHNICAL, OVERFLIGHTS, ACFT WISHING TO REFUEL. NO PAX FM TECHNICAL FLT LDG MAY DISEMBARK. DISEMBARKATION OF CARGO CREW IS PERMITTED SUBJ QUARANTINE LAWS APPLICABLE. CARGO FLT WILL BE SUBJ SANITISATION RQMNTS. ACFT IN STATE OF EMERG (ADDN SDBY STAFF WILL BE AVBL AT FAPE, FABL, FAUP, FAPP AND FAKN TO FALE, FAOR AND FACT.)

- REPATRIATION OF FOREIGN NATIONALS TO THEIR RESPECTIVE COUNTRIES ARE ALLOWED SUBJ THE FLW COND:
  - A) CHARTER FLT MAY ENTER WITH CREW, NO PAX ALLOWED.
  - B) CREW MAY NOT DISEMBARK AND OPR OF SUCH FLT TO ENSURE THAT FLT AND DUTY TIMES ARE ADHERED TO UNDER ALL CIRCUMSTANCES THROUGH PROVISION OF RELIEF CREW.
- EVACUATION OF SOUTH AFRICAN NATIONALS FM FOREIGN COUNTRIES ARE ALLOWED SUBJ THE FLW COND:
  - A) PAX SHOULD HAVE FULLY PAID RETURN FLT TICKET.
  - B) PAX WILL BE QUARANTINED FOR UP TO 21 DAYS.
  - C) CREW MAY DISEMBARK SUBJ MANDATORY QUARANTINE LAWS AS APPLICABLE.
- 3) AIR AMBULANCE OPS ARE ALLOWED SUBJ THE FLW COND:
  - A) MEDICAL EVACUATION FLT MAY NOT CARRY PAX OTHER THAN CREW AND PATIENTS.
  - B) CREW AND PATIENTS SHALL BE SUBJ APPLICABLE QUARANTINE LAWS. FLIGHTS NOT FOR THE PURPOSES OF REPATRIATION, EVACUATION, ACFT IN STATE OF EMERG, DOMESTIC AND INTL AIR CARGO OR AIR AMBULANCE OPS ARE REQ TO OBTAIN WRITTEN PERMISSION FOR EACH FLT FM DEPARTMENT OF TRANSPORT, PRIOR TO THE FLT DEPARTING.
- 4) AIR OPR ARE PERMITTED TO OPR DOMESTIC FLT TO TRANSPORT PASSENGERS FOR BUSINESS PURPOSES AND ESSENTIAL SER, INCLUDING ASSOCIATED MAINT RELATED FLT.
- 5) SKED PAX SER MAY ONLY OPR TO AND FM THE FLW AD: FAOR, FALE, FACT AND FALA. DIVERSION ALTN FABL.
- 6) ALL ABOVE OPS TO SUBMIT COVID-19 PROC TO SACAA FOR APPROVAL PRIOR TO OPS TO THABEDEN@CAA.CO.ZA.

  - A) COVID-19 SIGNED PROC CHECKLIST FOR AVIATION TRG ORGANISATION OPS TO BE SUBMITTED TO PERSONNEL LICENCING EMAIL: PEL.TRAINING(AT)CAA.CO.ZA
  - B) COVID-19 SIGNED PROC CHECKLIST FOR GEN AVIATION OPS TO BE SUBMITTED TO LAUBSCHERP@CAA.CO.ZA.
  - C) AERIAL WORK AOC OPS TO SUBMIT COVID-19 PROC TO SACAA FOR APPROVAL PRIOR TO OPS TO THABEDEN@CAA.CO.ZA.
- ALL FLIGHTS LISTED ABV TO ENSURE A COPY OF THE NOTAM, ALONG WITH ASSOCIATED DOCUMENTATION TO BE CARRIED ABOARD THE ACFT.
- RECREATIONAL AVIATION OPS ARE PROHIBITED, EXC FOR MAINT RELATED FLT. PRIOR APPROVAL REQUIRED FM SACAA.
- 7) PART 148 POST PRODUCTION TEST FLIGHTS PERMITTED.
