DETAILS OF EXEMPTION

The South African Civil Aviation Authority ("SACAA") published a general exemption from the provisions of Part 67.00.02 (8) of the Civil Aviation Regulations, 2011 ("CAR"), issued by the Director of Civil Aviation ("DCA") on 05 March 2020.

CAR 67.00.02 (8) stipulates that:

"a person under 60 years of age who submits to the Director a duly completed Class 5 medical self-declaration in the appropriate prescribed form, signed by a medical practitioner registered under the Health Professions Act, 1974 (Act No. 56 of 1974), shall be deemed to be a holder of a Class 5 medical certificate."

The said exemption placed a requirement for the affected applicants, who are holders of Class 5 licences below the age of 60 years, to submit a medical self-declaration in the appropriate prescribed form. In the event that an affected applicant has a medical condition listed in the prescribed form, the applicant is required to be examined by a designated aviation medical examiner.

The affected Class 5 licences are the following:

"Class 5—

- (i) paraglider licence;*
- (ii) powered paraglider licence;*
- (iii) powered paratrike licence;*
- (iv) weight shift or surface control hang-glider licence;*
- (v) powered hang-glider licence;*
- (vi) parachute licence;*
- (vii) powered parachute;*
- (viii) solo instructor for para-gliding or hang-glider and all powered versions thereof;*
- (ix) paragliding, hang gliding and parachuting student licence."*

The validity period for the said exemption was one hundred and eighty (180) days.

EXTENSION OF EXEMPTION

The SACAA hereby extends the said general exemption for a period of one hundred and eighty (180) days from the date of approval by the DCA, being 09 September 2020 or until the regulation development process affecting CAR 67.00.02 (8) is finalised with an amendment of the said regulation, whichever comes first.
